If your entry is accepted to participate in the test and you find that you will not be able to participate, **PLEASE INFORM THE TEST SECRETARY AS SOON AS POSSIBLE** so that an alternate entry can be notified of the opening.

Dogs Eligible to Compete: A dog must be six (6) months of age or older to participate in tracking events. As used in these regulations, the word "dog" refers to either sex. Dogs with a PAL (Purebred Alternative Listing), or ILP (Indefinite Listing Privilege), number must be spayed or neutered in order to compete. Note: Effective 01/01/14 – Dogs that have been listed with AKC Canine Partners, that have been spayed or neutered, may participate providing their listing number has been listed on the entry form and the test-giving club is holding an all-breed test and is offering participation for dogs enrolled in the AKC Canine Partners program.

DIRECTIONS TO THE TRIAL SITE

From SPOKANE, WA

- Interstate 90 West to US-395 South toward RITZVILLE/PASCO
- Merge onto I-182 West/US-12 West toward RICHLAND/PENDLETON
- Merge onto WA-240 West/BYPASS HWY via Exit 4 toward VANTAGE
- Turn LEFT onto WA-240
- Turn LEFT onto WA-225

From SEATTLE, WA

- Interstate 90 East to I-82 toward RICHLAND/PASCO
- Merge onto I-82 East, exit 110 toward YAKIMA
- Take the WA-225 North exit, Exit 96, toward WEST

From RICHLAND/BENTON CITY

- Turn LEFT onto WA-225, at stop sign go STRAIGHT on WA-225, crossing the river
- Turn RIGHT into park, if you get to WA-240, you've gone too far

From PORTLAND, OR BOISE

- Take I-84 towards THE DALLES
- Merge onto I-82 West via Exit 179 towards HERMISTON/UMATILLA (Crossing into Washington)
- Take the WA-225 North exit, Exit 96 toward WEST RICHLAND/BENTON CITY
- Turn RIGHT onto WA-225, at stop sign go STRAIGHT on WA-255, crossing the river
- Turn RIGHT into park, if you get to WA-240, you've gone too far
